Fees and funding



Introduction

Your financial wellbeing is a key component of your success on the Artificial Intelligence Masters. Below, you'll find all the information you need on the course tuition fee structure, financing options and payment methods.

How much are my course tuition fees?

Tuition fees for students starting their course between 1 September 2023 - 31 August 2024: £15,000.

The University of Leeds maintains a fixed fee policy, which means that your course fee is fixed at your point of entry. It will not rise in subsequent years of study.

Most students follow a module-by-module payment plan:

Starting course
1 September 2023 31 August 2024:
Nine module payments of
£1,450 and one project
module payment £1,950.

Continuing students must pay their tuition fee in full, by the payment deadline (one week prior to teaching start), in order to secure their place on the next module.

How do I pay?

Payments for your course can be made through our <u>online store portal</u>.

When you are ready to pay, your Enrolment Advisor will provide you with the link to our online store portal to secure your place and make your first payment.

After you have accepted your place on the course, your Enrolment Advisor will introduce you to the Student Success Team who will be there to assist you whilst you are on the course.

What funding is available to me?

If you need financial support to help pay for the course, there are two options available to you:

- Postgraduate loans.
- Third-party sponsorship.

Each of the above options may vary depending on your country of residence. For more information on financial support, speak to your Enrolment Advisor.

How can I get a postgraduate loan?

Students from England

Residents in England are eligible to apply for a government-funded postgraduate study loan of up to £11,836.

If you choose to apply for a loan, you will receive the first payment after your course start date once your university confirms that you've registered.

Please be aware, if you are using a postgraduate loan to finance your studies you will be required to complete the course within two years. Your fee instalment plan will reflect this obligation.

Students from outside England

If you're applying to study on the Artificial Intelligence Masters from outside England, you may still be eligible for a postgraduate study loan in your home country.

Contact your national department of education to find out whether you are eligible for a postgraduate study loan.

I have a third-party sponsor. What are my payment options?

There are two ways for your sponsor to pay for your course:

- The University of Leeds can invoice your sponsor directly.
- Your sponsor can pay on a moduleby-module basis through the University online store portal.

Students who choose the invoicing option must commit to completing the course within two years. Your sponsor must also commit to funding 100% of the yearly course fee.

If your sponsor is paying on a moduleby-module basis on your behalf, it is your responsibility to ensure fees are paid to the University at the appropriate times.

When will my sponsor receive an invoice?

Invoiced fees are due in two instalments - one for each year of your course. Your sponsor will receive their invoice each year within 30 days of your first module's start date. They will be required to pay the invoice within 30 days of receiving it.
